### **HUNTING DOG STAKE**

The Timucuan Weimaraner Club of Florida is pleased to announce that a non-regular Hunting Dog Stake will be offered Saturday and Sunday February 13 & 14, 2021 starting no sooner than 10am and beginning and concluding at the discretion of the HT Committee. Non-regular walking class open to all pointing breeds. This stake is designed to focus on dogs that have completed their JH title and are working towards the SH title. Each brace is 15 minutes. Dogs may be collared while on point and may run with a check cord. **Training collars used to control and train dogs including but not limited to collars with prongs, electronic collars used with transmitters, muzzles and head collars may not be used.**

**Eligibility:** Any dog that is eligible to compete in licensed AKC pointing breed field trials or hunt tests is eligible to run in the Hunt Dog Stakes. **Bitches in season may not compete. Refund of entry for bitches in season after closing date by vet's certification only.** Placements will be made at the end of each day and ribbons will be awarded for Places 1 thru 4.

A dog may run, but is not eligible for placements in a stake if it:

1. Has completed a Senior Hunter or Master Hunter title.
2. Has placed 1<sup>st</sup> in a broke dog stake.

Other breeds, or Weimaraner's, not owned by TWCF members, are eligible for placement at individual stakes only. Only Weimaraners owned by TWCF members are eligible for cumulative placements and the Hunting Dog of the Year Traveling Trophy. **Judging:** Each dog is judged on a dog's actual performance and its potential as a worthy hunting companion. **Entries:** Advance entries are \$25 (cash/check), \$26 PayPal via our website (weimtime.net) and must be received by Wednesday February 10, 2021. Entries may be made at the event for \$30 depending on bird availability and if there is time to run. Precedence in the running order will be given to advance entries.

**COURSES AND BIRDS**

The Master and Senior course is a single course with bird field and a designated shooting area for safety and the Junior course is a single course without bird field. Judges will be using Golf Cart or ATV's and/or walking. Native or liberated quail will be used in all tests. Only blank starter pistols may be used by handlers in this event. All live shooting will be done on course by Official Gunners. Horseback handling IS NOT permitted in any test. Tracking devices approved by AKC will be allowed. Hunt test will be run under a flexible format. The Hunt Test Committee reserves the right to change running order, order of tests, and/or modify courses as well as change and/or add judges if needed.

There shall be no training on the grounds of a Hunting Test on the day of the event prior to its start or during the running of the event. The definition of "the grounds" shall include any area used for the course(s) plus the parking area. Beyond that, the exact determination of "the grounds" is left to the determination of the event committee given the specifics of the location. Once an event has concluded, training is allowed provided it is allowed by the host club and the landowner/managing agency.
